Respected Sir/Ma'am,

With reference to Para 3.2 of the SEBI Circular No. SEBI/HO/DDHS/DDHS-RACPOD1/P/CIR/2023/172 dated October 19, 2023 as superseded by SEBI Circular No. SEBI/HO/DDHS/CIR/P/2018/144 dated November 26, 2018 a, listed entities identified as "Large Corporates" are required to file an Initial Disclosure within 30 days from the beginning of the financial year.

As per the said circular, the framework is applicable to listed entities (other than Scheduled Commercial Banks) which, as on the last day of the preceding financial year:

1. Have their specified securities or debt securities or non-convertible redeemable preference shares listed on a recognised stock exchange; and
2. Have outstanding long-term borrowings of Rs. 1,000 crore or more (excluding specified categories); and
3. Possess a credit rating of "AA"/"AA+"/"AAA", for unsupported bank borrowings or plain vanilla bonds which have no structuring/ support built in.

We wish to inform you that **Shyam Dhani Industries Limited ("the Company")** met only the first condition, i.e. its equity shares are listed on the NSE SME Emerge platform. However, the Company does not meet the second and third conditions regarding outstanding borrowings and credit rating.

Accordingly, the Company does not qualify as a "Large Corporate" under the aforementioned circular, and the requirement for Initial Disclosure for the Financial Year 2026-2027 is not applicable.
